Comes now the above named plaintiff, and complaining of the defendant alleges as follows:

1.

That the plaintiff is and at all times hereinafter mentioned was a corporation duly existing and organized under and by virtue of the laws of the State of Washington, with its principal place of business at Seattle, in King County, Washington and the plaintiff has paid all license fees due the State of Washington. The defendants Joseph Fleming and Robert Moore are residents of Seattle, Washington and are co-partners doing business under the name and style of Fleming & Moore.

That between the 16th day of February and the 3rd day of March, 1923, inclusive, the plaintiff at the instance and request of the defendants, sold and delivered to the defendants bottled milk and cream, the reasonable and agreed value of which is \$785.97, which said amount of the defendants agreed to pay upon demand, after delivery.

That the plaintiff has duly demanded of the defendant payment for said goods in said amount, but the defendant fails and refuses to pay for said goods or any part thereof and the whole
